

**INSTRUMENT OF GOVERNMENT FOR FEDERATED GOVERNING BODIES**  
**(Variation)**

1. The name of the federation is: The Arreton & Oakfield Federation.
2. The names and categories of the schools in the federation are:


Name	Type of Establishment
1. Arreton St George's Church of England Primary School	Voluntary Aided
2. Oakfield Church of England Primary School	Voluntary Aided

3. The name of the governing body is: "The Arreton & Oakfield Federation"
4. The governing body shall consist of the following (this depends on the number and categories of schools in the federation under Part 4 of the Federation Regulations):
  - a. Two Parent governors
  - b. One Head teacher governor
  - c. One Staff governor
  - d. One Local Authority governor
  - e. Twelve Foundation governors
  - f. Five Co-opted governors  
*(The total number of co-opted governors who are also eligible to be elected as staff governors under Schedule 3 of the Federation Regulations, when counted together with the staff governor and the head teacher, must not exceed one third of the total membership of the governing body.)*
5. Total number of governors: twenty two
- ~~6. [applicable if the term of office of one or more categories of governor is shorter than four years] The term of office of N/A [category of governor] is N/A [insert period between one and four years]~~
7. The name of the foundation body entitled to appoint foundation governors is: The Portsmouth Diocesan Board of Education after consultation with the Parochial Church Councils of St John The Baptist, Ryde and St George, Arreton.
  - (a) The holder of the following offices shall be foundation governors ex-officio; the principal officiating minister of St John The Baptist, Ryde and St George, Arreton.
  - (b) The Archdeacon of the Archdeaconry within which the school is situated shall be entitled to appoint a foundation governor to act in the place of any ex-officio foundation governor whose governorship derives from an office named in (a) above, in the event that the ex-officio foundation governor is unable or unwilling to act as a foundation governor or has been removed from office under regulation 21 of the Constitution Regulations or there is a vacancy in the office by virtue of which this governorship exists.

8. The Archdeacon of the Archdeaconry within which the school is situated is entitled to request the removal of any ex-officio foundation governor and to appoint any substitute governor.
9. There is a Trust deed for Arreton St George's Church of England (Aided) Primary School dated 1 November 1873; the Trustees are the Portsmouth Diocesan Board of Education. There is a Trust deed for Oakfield Church of England (Aided) Primary School dated 21 April 1845; the Trustees are the Portsmouth Diocesan Board of Education.
10. Recognising their historic foundation, the schools will preserve and develop their religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.

The schools aim to serve their communities by providing an education of the highest quality within the context of Christian belief and practice. They encourage an understanding of the meaning and significance of faith, and promote Christian values through the experience they offer to all pupils.

11. This instrument comes into effect on 24 May 2017.
12. This instrument was made by order of the Isle of Wight Local Authority on 4 May 2017.
13. A copy of the instrument must be supplied to every member of the governing body (and the head teacher if not a governor), any trustees and to the appropriate religious body.
